RENEWABLE LEASE AGREEMENT FOR INDIVIDUAL MEMORIAL TREE

WE, Groby Parish Council, in the County of Leicestershire (the grantor) in consideration of the sum of £_____ paid to us by:

DO HEREBY GRANT UNTO the said grantee his/her heirs and assigns the right to place a plaque adjacent to the memorial tree number _____ at Groby Village Cemetery for a period of time not exceeding **5 years** from the date hereof.

This right may be renewed on expiry of the **5 years** by payment of the appropriate fee ruling at the date. If at the end of the lease period the right to the tree is not renewed, then, in the absence of any other instructions, after a period of six months from the renewal date, the plaque will be removed from the tree. The plaque will be retained for six months for collection by the grantee. If not collected within that period it will be destroyed. The above right may be rescinded at any time during the lease period on the written instructions of the grantee who shall arrange collection of the plaque. It is the responsibility of the grantee to ensure that the rights are renewed. Although the grantor will endeavour to contact the grantee before expiry of the right no responsibility can be accepted for action taken in the absence of renewal of the right or alternative instructions from the grantee. All inscription work on the plaque shall be ordered through the grantor who will arrange for the work to be completed by an approved contractor. Apart from the plaque, supplied by the grantor, **no additional items or plants/bulbs are permitted on or in the vicinity of the Memorial Tree.** Any items in breach of this agreement will be removed and can be collected from the Cemetery Store up to 30 days after their removal.

PLEASE NOTE – ♦ Although uncommon, trees do, on occasions fall victim to disease and need to be felled. We will endeavour to plant a new tree as close to the original as possible. Where the original tree was mature, a stump will be left above ground, the grantee has the choice to place their plaque adjacent to the newly planted tree or the stump of the original.

I enclose a cheque for the initial 5-year adoption period for a tree memorial plaque.
